4) A \$35 service charge assessed for any returned checks. NO REFUNDS after Registration.

5) **NO OUTSIDE FOOD OR DRINK PERMITTED IN THE FACILITY.**

6) No cleats allowed: Turf shoes or sneakers only.

7) **All teams must wear numbered jerseys.** In the event of a conflict of jersey colors the first team listed will change jerseys.

8) Maximum Roster 16.
